- Radioactivity: Decay law  $(\tau, t_{1/2})$ , natural radioactivity, successive decay, artificial radioactivity basic  $\alpha$  decay process,  $\beta$  -decays and  $\gamma$  -transitions.
- Nuclear reactions: Q-value, threshold energy (E<sub>th</sub>), Internal Conversion, Decay Schemes.
- Interaction of radiation with matter: Interaction of heavy (α, p, d) and light (e<sup>-</sup>, e<sup>+</sup>), charged particles with matter, stopping power, interaction of gamma radiation with matter (Photoelectric, Compton and pair production)
- -Binding energy and the liquid drop model.
